Eye contact

Bathe the eye with running water for 15 minutes. Transfer to hospital for specialist examination. Consult a doctor.

ngestion

Wash out mouth with water. Do not induce vomiting. If conscious, give half a litre of water to drink immediately. If unconscious and breathing is OK, place in the recovery position. Transfer to hospital as soon as possible.

Inhalation

Consult a doctor. Remove casualty from exposure ensuring one's own safety whilst doing so. If conscious, ensure the casualty sits or lies down.
