4.0 First aid measures

4.1 Description of first aid measures

Skin contact

Wash immediately with plenty of soap and water.

Eye contact

Bathe the eye with running water for 15 minutes.

Ingestion

Wash out mouth with water. Do not induce vomiting. If conscious, give half a litre of water to drink immediately. Consult a doctor. Transfer to hospital as soon as possible.

Inhalation

Consult a doctor. Remove casualty from exposure ensuring one's own safety whilst doing so. If conscious, ensure the casualty sits or lies down.
