#### 4.1 Description of first aid measures

##### Skin contact

Wash immediately with plenty of soap and water. Remove all contaminated clothes and footwear immediately unless stuck to skin. Consult a doctor.

##### Eye contact

Bathe the eye with running water for 15 minutes. Consult a doctor.

##### Ingestion

Wash out mouth with water. Do not induce vomiting. If conscious, give half a litre of water to drink immediately. If unconscious, check for breathing and apply artificial respiration if necessary. Remove casualty from exposure ensuring one's own safety whilst doing so. If unconscious and breathing is OK, place in the recovery position. If breathing becomes bubbly, have the casualty sit and provide oxygen if available. Transfer to hospital as soon as possible.
