4.1 Description of first aid measures

Skin contact	Consult a doctor. Wash immediately with plenty of soap and water.
Eye contact	Consult a doctor. Bathe the eye with running water for 15 minutes.
Ingestion	Consult a doctor. If unconscious and breathing is OK, place in the recovery position. Transfer to hospital as soon as possible. Wash out mouth with water.
