## 4. First aid measures

### 4.1 Description of first aid measures

Skin contact	Consult a doctor. Drench the affected skin with running water for 10 minutes or longer if substance is still on skin. Remove all contaminated clothes and footwear immediately unless stuck to skin. Transfer to hospital if there are burns or symptoms of poisoning. Wash immediately with plenty of soap and water.
Eye contact	Consult a doctor. Transfer to hospital for specialist examination. Bathe the eye with running water for 15 minutes.
Ingestion	Consult a doctor. Do not induce vomiting. If conscious, give half a litre of water to drink immediately. If unconscious and breathing is OK, place in the recovery position. Transfer to hospital as soon as possible. Wash out mouth with water.
Inhalation	If unconscious and breathing is OK, place in the recovery position. Remove casualty from exposure ensuring one's own safety whilst doing so. Transfer to hospital as soon as possible. Consult a doctor.
