4. First aid measures

4.1 Description of first aid measures

Skin contact	Consult a doctor. Drench the affected skin with running water for 10 minutes or longer if substance is still on skin. Inhalation	If breathing becomes bubbly, have the casualty sit and provide oxygen if available. If conscious, ensure the casualty sits or lies down. If unconscious and breathing is OK, place in the recovery position. If unconscious, check for breathing and apply artificial respiration if necessary. Transfer to hospital as soon as possible. Consult a doctor. Remove casualty from exposure ensuring one's own safety whilst doing so.
