## 4. First aid measures

### 4.1 Description of first aid measures

<b>Skin contact</b>	Drench the affected skin with running water for 10 minutes or longer if substance is still on skin. Remove all contaminated clothes and footwear immediately unless stuck to skin. Transfer to hospital if there are burns or symptoms of poisoning.
<b>Eye contact</b>	Transfer to hospital for specialist examination. Bathe the eye with running water for 15 minutes.
<b>Ingestion</b>	Do not induce vomiting. Give 1 cup of water to drink every 10 minutes. If conscious, give half a litre of water to drink immediately. If unconscious and breathing is OK, place in the recovery position. If unconscious, check for breathing and apply artificial respiration if necessary. Transfer to hospital as soon as possible. Wash out mouth with water.
<b>Inhalation</b>	If breathing becomes bubbly, have the casualty sit and provide oxygen if available. If conscious, ensure the casualty sits or lies down. If unconscious and breathing is OK, place in the recovery position. If unconscious, check for breathing and apply artificial respiration if necessary. Transfer to hospital as soon as possible. Remove casualty from exposure ensuring one's own safety whilst doing so.

### 4.2 Most important symptoms and effects, both acute and delayed
