4.1 Description of first aid measures

If unconscious and breathing is OK, place in the recovery position. If unconscious, check for breathing and apply artificial respiration if necessary. Transfer to hospital as soon as possible. Remove casualty from exposure ensuring one's own safety whilst doing so.
