4.1 Description of first aid measures

Skin contact	Consult a doctor. Wash immediately with plenty of soap and water.
Eye contact	Consult a doctor. Bathe the eye with running water for 15 minutes.
Ingestion	Consult a doctor. If unconscious and breathing is OK, place in the recovery position. Transfer to hospital as soon as possible. Wash out mouth with water.
Inhalation	If breathing becomes bubbly, have the casualty sit and provide oxygen if available. If conscious, ensure the casualty sits or lies down. If unconscious and breathing is OK, place in the recovery position. Remove casualty from exposure ensuring one's own safety whilst doing so. Transfer to hospital as soon as possible.
