Remove all contaminated clothes and footwear immediately unless stuck to skin. Drench the affected skin with running water for 10 minutes or longer if substance is still on skin. Consult a doctor. Transfer to hospital if there are burns or symptoms of poisoning.

#### Eve contact

Bathe the eye with running water for 15 minutes. Transfer to hospital for specialist examination. Consult a doctor.
