## 4. First aid measures

### 4.1 Description of first aid measures

<b>Skin contact</b>	Consult a doctor. Drench the affected skin with running water for 10 minutes or longer if substance is still on skin. Remove all contaminated clothes and footwear immediately unless stuck to skin. Wash immediately with plenty of soap and water.

#### Personal precautions

Do not create dust. Eliminate all sources of ignition. If outside do not approach from downwind. If outside keep bystanders upwind and away from danger point. Mark out the contaminated area with signs and prevent access to unauthorised personnel. Notify the police and fire brigade immediately. Refer to section 8 of SDS for personal protection details.

### 6.3 Methods and material for containment and cleaning up

#### Clean-up procedures
