### 4.0 First aid measures

#### 4.1 Description of first aid measures

##### Skin contact

Wash immediately with plenty of soap and water. Remove all contaminated clothes and footwear immediately unless stuck to skin. Drench the affected skin with running water for 10 minutes or longer if substance is still on skin. Consult a doctor. Transfer to hospital if there are burns or symptoms of poisoning.

### Eye contact

Bathe the eye with running water for 15 minutes. Transfer to hospital for specialist examination. Consult a doctor.

### Ingestion

Wash out mouth with water. Do not induce vomiting. If conscious, give half a litre of water to drink immediately. Give 1 cup of water to drink every 10 minutes. If unconscious, check for breathing and apply artificial respiration if necessary. If unconscious and breathing is OK, place in the recovery position. Transfer to hospital as soon as possible.

### Inhalation

Remove casualty from exposure ensuring one's own safety whilst doing so. If conscious, ensure the casualty sits or lies down. If unconscious and breathing is OK, place in the recovery position. If breathing becomes bubbly, have the casualty sit and provide oxygen if available. Transfer to hospital as soon as possible.

## 4.2 Most important symptoms and effects, both acute and delayed

### Skin contact

There may be mild irritation at the site of contact. Blistering may occur. Progressive ulceration will occur if treatment is not immediate.

### Eye contact

There may be irritation and redness. Corneal burns may occur. May cause permanent damage.

### Ingestion

There may be soreness and redness of the mouth and throat. Corrosive burns may appear around the lips. Inhalation of fumes from the stomach may cause symptoms similar to direct inhalation. Blood may be vomited. There may be bleeding from the mouth or nose.

### Inhalation

There may be shortness of breath with a burning sensation in the throat. Exposure may cause coughing or wheezing. Drowsiness or mental confusion may occur. There may be loss of consciousness. Convulsions may occur.
