## 4. First aid measures

### 4.1 Description of first aid measures

<b>Skin contact</b>	Consult a doctor. Drench the affected skin with running water for 10 minutes or longer if substance is still on skin. Remove all contaminated clothes and footwear immediately unless stuck to skin. Transfer to hospital if there are burns or symptoms of poisoning. Wash immediately with plenty of soap and water.
