#### 4.1 Description of first aid measures

Skin contact

Bathe the eye with running water for 15 minutes. Transfer to hospital for specialist examination. Consult a doctor.

Wash out mouth with water. Do not induce vomiting. If conscious, give half a litre of water to drink immediately. Give 1 cup of water to drink every 10 minutes. If unconscious, check for breathing and apply artificial respiration if necessary. If unconscious and breathing is OK, place in the recovery position. Consult a doctor. Transfer to hospital as soon as possible.

#### Inhalation

Consult a doctor. Remove casualty from exposure ensuring one's own safety whilst doing so. If conscious, ensure the casualty sits or lies down. If unconscious and breathing is OK, place in the recovery position. If breathing becomes bubbly, have the casualty sit and provide oxygen if available.
