4.1 Description of first aid measures

Skin contact	Consult a doctor. Drench the affected skin with running water for 10 minutes or longer if substance is still on skin. If unconscious and breathing is OK, place in the recovery position. If unconscious, check for breathing and apply artificial respiration if necessary. Transfer to hospital as soon as possible. Consult a doctor. Remove casualty from exposure ensuring one's own safety whilst doing so.
